Packers & Stockyard Surety Bonds are required by State and Federal Governments.

The surety bond guarantees the Broker/Dealer will make payment to the supplier of stock and other Stockyard and Livestock goods. Specific surety bond forms are required and the principal is required to provide the state's form. To make sure we provide the correct surety form:

1. *It is important to tell us if you **SELL** livestock on commission.*
2. *If you **BUY** on commission or as a dealer*
3. *If you **CLEAR** transactions for others.*
4. *If you **BUY** as a Packer.*

The amount of the surety bond varies from state to state.

In most cases we can approve your request within 24 hours.
